
**ADDENDUM AND CORRIGENDUM TO DM 104, SERIES OF 2022 “UPDATES ON THE
CONDUCT OF THE ENGLISH PROFICIENCY TEST (EPT)”**

TO: Assistant Schools Division Superintendents
Chiefs, CID and SGOD
All Others Concerned

1. Your attention is hereby directed to Item No. 1 of DM no. 104 s. 2022, that the Venue/Testing Center in Mabinay Central School shall be changed to **Mabinay National High School** and Item No. 4, the Personnel and ICT Coordinators in Bacong CES Mr. Tristan Jamito shall be changed to **Mr. Joseph Anthony Juntilla**.
2. Additional requirements for Item No. 3 upon taking the exam are as follows:
 - a. COVID-19 Vaccination Card are required for those who are Fully Vaccinated. Likewise, CB-EPT examinees who had only one dose of COVID-19 vaccine are allowed to take the test and are required to upload the vax card or certificate in the Google Drive provided.
 - b. Examinees who are NOT vaccinated should present a negative Antigen result taken a day before the exam.
 - c. Pregnant Examinees should seek medical certificate from their OBGYN or RHU stating the gestational age of baby.
3. To ease the access on the uploading of the vaccination card, please upload your vaccination card according to your assigned Testing Center:
