
1. Pursuant to Republic Act (RA) 9155 (Governance for Basic Education Act of 2001) which envisions a curriculum that shall promote holistic growth of the Filipino learners, and Article 28 of the United Nations Conventions on the Right of the Child which is "Education is free to all", this office advocates the program which saves all Filipino learners from dropping out. Hence, the Drop Out Reduction Program (DORP) which aims to reduce dropout rates and improve learning outcomes and retention rates of learners is strengthened.
2. On this regard, this office requests the districts to submit a consolidated report on Learners At-Risk of Dropping Out for the First and Second Quarter of SY 2021-2022 on or before March 3, 2022.

- 1) Modules received on time but not returned as scheduled
- 2) Modules are not received on time and not submitted as scheduled.
- 3) Activities in the modules/summative tests are not completely accomplished

Legend:

- L : Low- means Twice (2) but not successive
- M : Moderate- means Thrice (3) or more but not successive
- H : High- means Thrice (3) but successive

Causes:

- F - Family: Family Problems; Parents attitude (Lacks support & guidance)
- I - Individual: Lack interests; distractions; child abuse, malnutrition/illness
- C - Community: Distance between home and school, calamities/disasters; armed conflict
- S - School: Teachers not able to prepare modules/summative tests on time
- F - Financial: Learner is working to earn a living
