2022 CHILD PROTECTION PROGRAM, PROJECTS and ACTIVITIES (CP-PPAs)

To : Schools Division Superintendents
Assistant Schools Division Superintendents
All Others Concerned

1. Article XV, Section 3(2) of the 1987 Constitution provides that the State shall defend the "right of children to assistance, including proper care and nutrition with special protection from all forms of neglect, abuse, cruelty, exploitation and other conditions, situations prejudicial to their development."
2. In line with this, the Philippines as a signatory to the United Nations Convention on the Rights of the Child (UN CRC), is mandated under Article 19 thereof to protect the child from all forms of physical, mental violence, injury or abuse, neglect or negligent treatment, maltreatment or exploitation, including sexual abuse while in the care of parents, legal guardians, or any other person who has the care of the child. Article 28 of the UN CRC also recognizes the rights of the child to education with the view of achieving this right progressively and on the basis of equal opportunity and obliges the state parties to take all appropriate measures to ensure that school discipline is administered in a manner consistent with the child's human dignity and conformity with the said convention.
3. Furthermore, DepEd Order No. 40, s. 2012, entitled DepEd Child Protection Policy was issued. The Child Protection Policy pronounces the Department's zero-tolerance policy against all forms of abuse, violence, exploitation, neglect, discrimination and all other conditions prejudicing the learners.
4. In this regard, Schools Division Offices are hereby directed to submit a consolidated CP-PPAs of your schools through the CPU Focal Person. Attached is Annex A for the consolidated report for submission to this Office on or before May 30, 2022 through ESSD or email to melissa.paradela@depd.gov.ph
