This is in relation to the letter request to conduct **Learning and Development (L and D) Activities** within Dumaguete City dated last December 27,2021. In reference to the National IATF GUIDELINES ON THE IMPLEMENTATION OF ALERT LEVELS SYSTEM FOR COVID-19 RESPONSE IN PILOT areas dated November 18,2021, Section 5.3.a states that, "The following establishments, or activities, shall be allowed to operate, or be undertaken at a **maximum of 50% indoor venue capacity for fully vaccinated individuals** and those below 18 years of age, even if unvaccinated. **Provided further, that all workers /employees of these establishments are fully vaccinated against COVID-19** and minimum public health standards shall be strictly maintained."
