**UPDATE ON THE TEACHERS' REPORTING TO SCHOOL  
ON MAY 2 to 13, 2022**

TO : Assistant Regional Director  
Schools Division Superintendents (SDSs)  
Assistant Schools Division Superintendents (ASDSs)

1. The Department of Education (DepEd) through the Office of the Secretary of Education Leonor Maqtolis Briones has issued an Official Statement on April 29, 2022 relative to the "*DepEd Approves Recommendation of Regional Directors and Field Operations to Allow Teachers not to Report On-Site on May 2-13, 2022*".
2. In view of the statement of Secretary Leonor Maqtolis Briones, this Office hereby directs all concerned the following :
  1. **Allow the teachers not to report on-site on May 2 to 13, 2022, except in the exigency of the service or those who will serve in the elections and prepare the classrooms/schools as polling places and post-election activities;**
  2. **Teachers not serving in the elections shall continue to attend to their tasks including the accomplishment of school forms, preparation of instructional materials, preparation of learning plans, and evaluation of learner's outputs/portfolios, during the period.**
3. The Schools Division Superintendents are advised to institute and make an appropriate guidance in the implementation of the above directive.
4. Immediate dissemination and compliance of this Memorandum is desired.
