#### AVAILABILITY OF COVID-19 VACCINES IN REGION VII

To: Schools Division/City Superintendents
Officers-in-Charge of Regular/Interim Divisions
All Others Concerned

- 1. The new COVID-19 variant like Omicron is a reminder that the COVID-19 pandemic is far from over. It is therefore essential that the people get the vaccine when available and continue to follow existing advice on preventing the spread of the virus, including physical distancing, wearing masks, regular handwashing and keeping indoor areas well ventilated.
- 2. Section 15 of Article II of the 1987 Constitution of the Republic of the Philippines states that "The State shall protect and promote the right to health of the people and instill health consciousness among them."
- 3. DepEd Task Force COVID-19 (DTFC), Memorandum No. 586 entitled, "Clarifications on DTFC Memorandum No. 575 entitled 'IATF Vaccination Requirement for Reporting On-Site Beginning on December 2021' states that:

"As such, offices and schools have been instructed to coordinate with their respective Regional VOCs and /or Local VOCs to inquire whether there are sufficient supplies of COVID-19 vaccines in their respective areas, determined by the NVOC".

- 4. In view thereof, attached is the Certification issued by the Visayas Vaccination Operations Center stating that there are sufficient supplies of COVID-19 vaccines in the whole Region VII.
