#### Enclosure 1

#### A. Possible Reasons for SEB Lock

- 1. Connected Peripherals mainly attempt for 2nd display screen
- 2. Device setup relative to battery management: sleep and lock setup after x number minutes of inactivity (plugged or in battery)
- Residual configuration from previous test that utilized SEB

  To resolve completely uninstall existing SEB before re-installing the latest version
- 4. User initiated locking of the device (windows + L or closing down the monitor)

#### B. Incomplete Test Statuses of an Examinee on the Screen of Live Proctors

Let XX.x be any number

Status	Meaning	
0.0%	no status/ examinee does not access the link yet	
0.0% inactive	examinee has started the test (preliminaries) or going into the virtual room	
0.0% WAITING	examinee is waiting for the live proctor to connect and start the exam	
XX.x% WAITING	examinee is waiting for the live proctor for re-admission	
XX.x % inactive	examinee has started the test but gets disconnected (needs to go to preliminaries again to go back to the virtual room	
XX.x% recording	examinee is currently taking the test	
XX.x Recording - expired	examinee is taking the test; the test link validity has expired	
100% Scoring	the examinee has finished the exam	
0.0% Suspended	examinee got suspended at the ID verification phase	
XX.x% suspended	examinee met the threshold for suspicious activities; examinee can no longer go back
