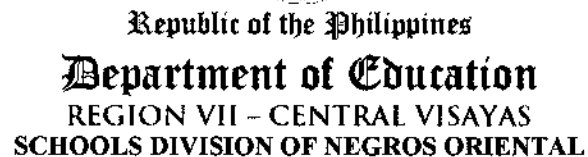
1. The following should have been the contents of items 1-2 of the Division Memorandum 567, s. 2022:

Then, the District Office shall make a summary report of all schools.   - b. All teaching and nonteaching personnel may be examined by the Division Medical Officer and Dentists or any government-affiliated medical doctor and dentist.
  - c. Enclosed are the templates which will be used in making the consolidated reports.

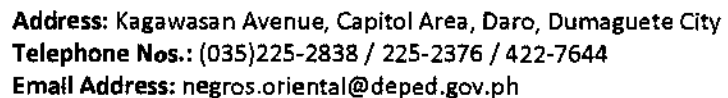
