**SIMULTANEOUS CONDUCT OF THE
STUDENT-LED SCHOOL WATCHING AND HAZARD MAPPING**

1. Student-Led School Watching and Hazard Mapping is an annual activity to engage learners in the implementation of disaster risk reduction and management (DRRM).
2. In compliance to the **DepEd Order No. 23 s. 2015** titled “**Student-led School Watching and Hazard Mapping**”, the Schools Division of Negros Oriental, through the Disaster Risk Reduction and Management (DRRM), informs the field of the **Simultaneous Conduct of the Student-led School Watching and Hazard Mapping** on **August 26, 2022** at exactly one o’clock (**1:00 PM**) in the afternoon.

 - Hazard Map Action Plan
 - Student-led School Watching and Hazard Mapping Activity Implementation
5. District DRRM Team headed by PSDS/DICs and District DRRM Coordinators (Elementary/Secondary) are hereby directed to monitor and evaluate the conduct of the said activity.
