**DIVISION GUIDELINES ON THE IMPLEMENTATION OF LEARNING MODALITIES
FOR SY 2022-2023**


To: Assistant Schools Division Superintendent

1. This office hereby disseminates **Division Guidelines on the Implementation of Learning Modality for SY 2022-2023** in adherence to DepEd Order No. 034, s. 2022 titled School Calendar and Activities for the School Year 2022-2023.
2. The field is to be guided on the following to slowly transition from limited face-to-face to full face-to-face classes:
 - a. The blended learning modality – limited face-to-face and distance modular learning shall be observed from August to October 2022;
 - i. Schools with classrooms that can accommodate ALL learners in a class/section shall have 4 days of in-person classes and 1-day modular distance learning,
 - ii. Schools with classrooms that CANNOT accommodate ALL learners in a class/section shall observe double shift – 2 days in-person and 3 days modular distance learning, and
 - iii. Schools affected by typhoon Odette may divide the learners and prepare a flexible class schedule applicable to the existing class size and available classrooms or may coordinate with Barangay council for learning spaces to conduct in-person classes.
 - b. Vaccinated teachers shall handle in-person classes;
 - c. Unvaccinated teachers shall handle distance learning (modular) and perform other functions relative to instruction except handling in-person classes while waiting for the new guidelines;
 - d. The time allotment for in-person class hours shall be based on Annex 1 (Elementary Education) and Annex 2 (Secondary Education) of DepEd Order 21, s. 2019;
 - e. Class programs shall be prepared by the teachers, recommended for approval by the school head and to be approved by the respective PSDSs;

- f. Existing modules shall be utilized by schools and shall be supplemented by other learning materials to enhance learning; and
 - g. Schools shall conduct inventory on the available modules and to be reported to the Learning Resource (LR) through Miss Rosela Abiera.
- 3. Schools shall ensure that classrooms are prepared during the opening of classes and include in the Brigada Eskwela activities, e.g. 5's in the respective classrooms, removing extra furniture, removing barriers, etc.
 - 4. Schools shall conduct orientation/meeting with parents relative to the learning modalities to prepare the resumption of 5 days in-person classes in November 2022.
 - 5. Schools shall strictly adhere to DepEd Order 34, s. 2022 on the prevention of COVID 19 and other infectious diseases and the activities to be undertaken to ensure the continuity of education amid these challenges.
 - 6. Document the best practices and the concerns, issues, gaps, and problems (CIGPs) during the blended learning modality in the first three months.
 - 7. The Public Schools District Supervisors/District In-charges/District Caretakers shall oversee the implementation of relevant learning modalities and provide necessary technical assistance (TA).
 - 8. For information, guidance, and compliance.
