#### BACKGROUND INFORMATION

In support of the upskilling and reskilling of educators through professional development, the National Educators Academy of the Philippines (NEAP) in partnership with the Philippine Normal University (PNU) implemented the Linking Standards and Quality Practice (LiSQuP) program, a two-year postgraduate customized program for teachers and school leaders to aid in the upgrading of education quality.

LiSQuP's primary goal is to ensure that teachers and school leaders are equipped and engaged in the achievement of the expectations of the Philippine Professional Standards for Teachers (DepEd Order No. 42, series of 2017), Philippine Professional Standards for School Heads (DepEd Order No. 024, series of 2020), and Philippine Professional Standards for Supervisors (DepEd Order No. 025, series of 2020). It is also anchored on DepEd Order No. 11, s 2019 which aims to make progress in upgrading education quality in the Philippines through the transformation of the NEAP. The following are its NEAP Recognized Programs:

The actual program implementation started in September 2021 and the 1st Interim Report by PNU was held last December 2021 at Ace Hotel, Pasig City in which the Graduate College Admission Test (GCAT) data and Cohort 1 participants' engagement status were presented. The 2nd Interim Report and Workshop was held last June 23 and 24 at B Hotel, Quezon City with the following aims:

- provide updates of the program delivery from January to June 2022;
- present the innovations of the program that addresses a standards-based professional development program; and
- discuss the recommendations to further strengthen the implementation of LiSQuP moving forward.

The activities will be participated in by the NEAP Management Team, NEAP-PDD PDI Team and M&E Team, PNU Executives, PNU LiSQUP Team and selected LiSQuP scholars.

In the same way, PNU and NEAP see the impact and importance of involving the Regional Directors, HRDD Chiefs, Regional and Division LiSQuP Focals in this kind of Interim Report and Workshop in order to better strengthen their understanding, foster coordination, and align data and information.

Hence, NEAP and PNU will conduct LiSQuP Regional Online Interim Report and Workshop with the Regional Directors, LiSQuP Regional and From August 10 to 12, 2022, 2:00PM-3:30PM via Zoom.
