- d) Certificate of Employment, or appointment or contract of service
- e) Certificate of eligibility/rating/license
- f) Outstanding/meritorious Accomplishments
 - Awards - the certificate/medal/plaque of recognition shall be supported by any evidence that a search is conducted (for non-DepEd applicants)
 - Innovation - as to its implementation, it should be fully and properly documented (e.g. with narrative feedback or evaluation report)
 - Research and Development Project - must be approved by the Schools Division Superintendent
 - Publication - with analysis and must be educational
 - Consultancy/Resource Speaker - must be supported by any of the ff: memorandum, invitation letter, authority to travel, etc.
- g) Official Transcript of Records/certification if completed academic requirements for Masteral or Doctorate Degree duly certified by the school registrar;
- h) Certificate of trainings/seminars/scholarship grant attended; and
- i) Other pertinent documents with table of contents and proper tabbings.
