1. The Department of Education (DepEd) has announced the opening of classes for SY 2022-2023 on August 22, 2022 and all teaching and non-teaching personnel are currently on its preparations.
 2. Relative to this, all Schools Division Superintendents are hereby directed to ensure the on-site reporting of teachers, either vaccinated or unvaccinated.
 3. All are reminded of the strict compliance of minimum public health and safety protocols shall be observed at all times, such as :
 - a. Wearing of mask
 - b. Social and physical distancing
 - c. Disinfect/spraying of alcohol/sanitizer
 - d. Proper waste disposal
