**LAUNCHING OF THE 2022-2023 BE-LEARNING CONTINUITY RECOVERY PROGRAM**

1. This Division continues its desire to provide quality education to all the learners despite the challenges of times brought about by the pandemic. True to its goal of pursuing education in the new normal, issues which were identified in the previous years were given priority in its intervention plans, most especially on the learning loss in literacy and numeracy.
2. The Curriculum Implementation Division recognizes the significant contribution of literacy and numeracy as foundational skills in achieving the rest of the academic skills, thus focusing these on the recovery interventions.
3. One of the intervention plans which tries to address issues related to challenges in literacy, numeracy and other academic concerns is Literacy Enhancement and Numeracy Development or (**LEND**) thru Diagnose learners, Enrich least mastered competencies Assess enriched skills, and Lesson new competencies or (**DEAL**). This program is aided with the different learning resources which were developed and utilized during the distance learning modality thru modules like worktexts, video-recorded lessons, modules, activity sheets, etc. With the positive result obtained during the initial assessment conducted in the first wave of implementation of the program, it is but significant to launch the program close to the implementers which will be done on **December 2, 2022**, in the respective districts.
4. The District Supervisors are requested to strategize the conduct of the activity and ensure that minimum health protocols are observed. Thus, everyone is expected to follow the health protocols. Further, the **best school recovery program** in the district shall be identified. The criteria shall be posted on a separate communication.
5. Expenses incurred relative to the conduct of the activity shall be charged against school MOOE while for the division personnel monitoring the activity shall be charged against the Division MOOE, all subject to the usual accounting rules and regulations.
6. Immediate and wide dissemination of this memorandum is desired.
