

**2022 NATIONAL MID-YEAR EVALUATION AND PLANNING WORKSHOP FOR
REGIONAL AND DIVISION DRRM COORDINATORS**

To: Schools Division Superintendents
Region and Division DRRM Coordinators

1. The Disaster Risk Reduction and Management Service (DRRMS) will conduct the 2022 National DRRM Mid-Year Evaluation and Planning Workshop (Face-to-Face) on June and July 2022. DepEd Region 7 together with other Region IV-B, VI and VIII is scheduled on June 28-July 1, 2022 to be held at Crown Regency Hotel, Jones Ave., Cebu City.
2. The 4-day activities, inclusive of travel time, have the following objectives:
 - a) Provide updates and status of the implementation of FY 2022 1st Semester Disaster Risk Reduction and Management (DRRM), Climate Change Adaptation and Mitigation (CCAM), and Peacebuilding programs, projects and activities (PPAs) in the regions and divisions.
 - b) Introduced standard DRRM, CCAM and Peacebuilding Monitoring Tools and Templates.
 - c) Present the DRRMS Results-Based Planning Framework.
 - d) Present the DRRM, CCAM and Peacebuilding newly issued policies.
3. The workshop is in line with the mandate of DRRMs to implement efficient and effective DRRM, CCAM and Peacebuilding PPAs across the country.

- d) Those who are unvaccinated will be required to submit a negative result of Reverse Transcription-Polymerase Chain Reaction (RT-PCR) test Forty-Eight (48) hours before the workshop. Payment for the RT-PCR test will be charged personal to the participants following the Inter-Agency Task Force for the Management of Emerging Infections Diseases (IATF) Resolution No. 148-B (Annex A) and DepEd Task Force COVID-19 Memorandum No. 575 dated December 7, 2021,
