

DATE : May 5, 2022

The Office of the Assistant Secretary for Alternative Learning System (ALS) through the Bureau of Alternative Education (BAE) will conduct the 17th National Consultative Conference for Regional ALS Focal Persons and Select Division ALS Focal Persons on May 30 to June 2, 2022 (*inclusive of travel time*) in So La Hotel, Laoag, Ilocos Norte, Region I.

The said activity aims to discuss the following:

- a. Operationalization/construction and inventory of ALS Community Learning Centers (CLCs);
- b. Plan for the Implementation of Indigenous Peoples (IP) Education (IPEd) in ALS;
- c. Report on the Utilization of Program Support Fund for FY 2021-2022; and
- d. Updates on the Conduct of Presentation Portfolio Assessment (PPA) Year 3.

In view of this, may we invite the Regional ALS Focal Persons and two (2) select Division ALS Focal Persons to participate in the abovementioned activity. One of the Division ALS Focal Persons to be identified should be knowledgeable about the **Community Learning Center catering to the Indigenous Peoples community** and should be able to provide inputs during the discussion on the operationalization/construction of CLCs and implementation of IP Education in (IPEd) in ALS.

Each region shall prepare and submit a 10 -15 minute presentation report highlighting the following:

- a. Update on the conduct of Presentation Portfolio Assessment (PPA) Year 3;
- b. SY 2021-2022 enrollment data;
- c. ALS SHS data;
- d. ALS in SBM Data (of the 100 pilot schools in SY 2020-2021, covered by DepEd Order No. 21, s. 2021; and
- e. Status of Program Support Fund (PSF) Utilization for FY 2021-2022, covered by DepEd Order No. 27, s.2021.

Regional ALS Focal Persons is directed to strictly follow the allotted time for the presentation of their report.

Further, **Dr. Antonio Laceste**, Regional ALS Focal Person of Region 1, as the host region, is also requested to assign at least two (2) documenters during the conference. They are expected to submit the minutes of the meeting to the BAE on June 15, 2022.

The first meal to be served shall be breakfast on May 30, 2022, and the last meal shall be a morning snack on June 2, 2022.

Transportation, board and lodging, and other expenses relative to the conduct of the activity shall be charged against the FY 2022 ALS Current Funds. **Travelling expenses of participants shall be reimbursed through the fund to be downloaded to their respective regions subject to the usual government accounting and auditing rules and regulations.** In case the downloaded fund for such is not enough, the excess amount shall be charged against local funds.

The BAE shall require all participants to provide their proof of COVID-19 vaccination and booster shot in compliance with the COVID-19 Alert Level System set by the national and local Inter-Agency Task Force for the Management of Emerging and Infectious Diseases (IATF), as well as the most recent DepEd rules and/or policies.

Ms. Clarisa R. Toribio, *Education Program Specialist II* of the Bureau of Alternative Education - Program Management and System Development Division (BAE-PMSDD), shall coordinate with the Regional ALS Focal Persons regarding their confirmation and travel schedule for the preparation of logistical arrangements the host region.
