


**ANNOUNCING THE CONDUCT OF PALARONG PAMBANSA BOXING VISMIN CUP:  
LIMITED FACE-TO-FACE BOXING COMPETITION AND A TWO-DAY REFRESHER  
COURSE FOR OFFICIATING OFFICIALS**

1. This is in connection with the communication signed by **Dir. Joel S. Erestain**, CSEE, Director III - Palarong Pambansa Secretariat relative to the conduct of the invitational Palarong Pambansa Limited Face-to-Face Boxing Competition VisMin Cup in partnership with the City Government of Cebu at the Cebu City Sports Center on July 10-16, 2022.
2. In line with the conduct of the boxing competition, there will be a **FREE Face-to-Face Refresher Course** for DepEd Boxing Coaches and Referees offered by Cebu City on July 10-11, 2022, at the Cebu City Sports Center.
3. **School Division Offices** are given Five (5) slots each to come up with the 100 guaranteed participants allocated for DepEd Region VII. Participants to this Refresher Course shall be identified by the Division Sports Officer and endorsed by the Schools Division Superintendent. **Travel Order** shall be issued by the concerned Schools Division Office.
4. **Travel, food, accommodations, and other incidental expenses incurred by the participating coaches and referees for the refresher course shall be charged against the Local Funds (SEF/School/Division MOOEs)** subject to the usual Audition Rules and Regulations.
