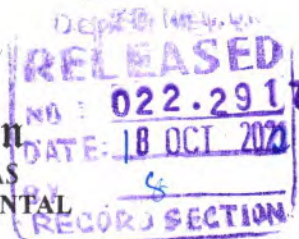

**Hybrid Writeshop on the Development of Bridging Primer 3**

To: Schools Division Superintendents

1. The Bureau of Learning Delivery – Teaching and Learning Division will conduct a series of *Hybrid Writeshop on the Development of Bridging Primer 3*. The activity aims to develop the Primer Teacher's Guide and Learner's Material for teaching and learning support materials in reading. This is in support to sustain the implementation of the MTB-MLE in relation to bridging languages from a child's Mother Tongue (L1) to Filipino (L2) and to English (L3) in order to ensure the smooth language transition and learning reading, and strengthen the goal of making every learner a successful reader.
